Description of the data MDM Props LTD may collect

Personally Identifiable data

MDM Props Ltd collects personally identifiable data (i.e. data from which you can be identified, such as but not limited to name, address, telephone number or e-mail address) only when it is asked for and/or you voluntarily submit it to us on this Site.

We may use the data to respond to your requests, improve our level of service and the content of our website; provide you with tips, helpful information, offers and updates; notify you of new MDM Props Ltd services; seek your views on our services; and for our own internal purposes.

Non-Personally Identifiable data
